2. Insert the name(s) of the other party on the second line on the top left side of the form. You are the “Petitioner” and the other party is the “Respondent”.
3. Insert the case number from your custody order on the top right side of the form. Answer all the questions on the form completely.
4. Complete the Criminal Record/Abuse History Verification.
5. Complete the document titled “Order” but leave all lines below the child’s initials and age blank.
6. You **MUST** also attach a copy of your current custody Order; failure to attach a copy of the current order will result in this Court not setting a hearing date. A copy of your current custody order may be obtained from the Wayne County Prothonotary’s Office located on the 2nd Floor of the Courthouse.
7. Place any Confidential Information on the Form labeled CONFIDENTIAL INFORMATION FORM; this includes the full names of any minor children. You need not include additional Confidential Information (such as Social Security Numbers) unless this information is required by law, ordered by the court, or referenced in your document.
8. You are responsible for ensuring that your document complies with all rules regarding confidential information and for signing the verification ensuring that your document is in compliance.

 Pa.C.S. § 5337 and Pa.R.C.P. 1915.17 regarding relocation.
