1. APPLICANT **MUST** BE 21 YEARS OF AGE AND HAVE A VALID DRIVERS LICENSE OR ID CARD.
2. IF YOU ARE A **NON-RESIDENT**, YOU **MUST** HAVE AN **UNRESTRICTED** LICENSE TO CARRY FROM YOUR HOME STATE.
3. READ AND COMPLETE THE APPLICATION FOR PENNSYLVANIA LICENSE TO CARRY FIREARMS.
(ALL QUESTIONS MUST BE ANSWERED)
4. YOU MAY APPLY IN PERSON, BY MAIL OR ONLINE AT THE FOLLOWING WEBSITE:

5. ENTER YOUR PHYSICAL ADDRESS AS WELL AS YOUR MAILING ADDRESS P.O. BOXES ARE ACCEPTABLE FOR A MAILING ADDRESS ONLY.
6. IF YOU WERE BORN OUTSIDE THE UNITED STATES, PLEASE ATTACH A COPY OF YOUR **NATURALIZED CITIZENSHIP CERTIFICATE OR PASSPORT**.
7. PHOTOS ARE REQUIRED AND WILL BE TAKEN AT THE SHERIFF'S OFFICE.
8. **FEES ARE REQUIRED FOR NEW OR RENEWAL APPLICANTS.**
9. **PERMIT TO CARRY FEE IS \$20.00. \$5.00 OF THAT FEE IS NON-REFUNDABLE SHOULD YOU BE DENIED.** CASH, CHECK OR MONEY ORDER. MAKE CHECKS OR MONEY ORDERS PAYABLE TO "WAYNE COUNTY SHERIFF'S OFFICE".
10. **RENEWAL APPLICANTS:** MUST HAVE THEIR VALID DRIVERS LICENSE AND CURRENT WAYNE COUNTY CARRY PERMIT.
11. **IMPORTANT:** BY SIGNING THIS APPLICATION YOU ARE SIGNING A LEGAL DOCUMENT. ANY FALSE INFORMATION ON ANY OF THE QUESTIONS 30-33 ON FORM WILL RESULT IN PROSECUTION.
12. SIGNIFICANT CHANGES MADE TO TITLE 18 6109 RELATING TO A PA LICENSE TO CARRY ARE AS FOLLOWS: INDIVIDUALS ARE **NOW REQUIRED TO NOTIFY** THE SHERIFF IF THEY BECOME INELIGIBLE AFTER A LICENSE HAS BEEN ISSUED TO THEM. i.e., **ACTIVE PFA, DUI, ANY ARREST OR CONVICTIONS.**
13. APPLICATIONS MAY BE MAILED OR DROPPED OFF IN PERSON. **MUST** HAVE PAYMENT FOR PROCESSING. MAILING ADDRESS IS AS FOLLOWS: **WAYNE COUNTY SHERIFF'S OFFICE, 925 COURT STREET, HONEDSDALE, PA 18431.**
